# What is this product?

#### Type

PLACEURO GOLD MINES (Part C CAP EUR) is an Investment company with variable capital (société d'investissement à capital variable) organized under the laws of the Grand Duchy of Luxembourg and having the status of an undertaking for collective investment in transferable securities under UCITS Law (17 December 2010).

#### **Objectives**

The assets of this Sub-Fund shall be invested: mainly in listed transferable securities, including shares of gold mining companies, silver, platinum, other metals and diamond mining and processing companies, up to 10% of its assets in other transferable securities or units of UCITS pursuing equity strategies and approved in accordance with the Directive 2009/65/EC Cash may also be held on an ancillary basis. The investment objective of this Sub-Fund is to seek to replicate as closely as possible the performance of the NYSE Arca Exchange Gold BUGS Index.

#### Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below.

The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment.

The Sub-Fund has been established for an unlimited period of time and is open-ended.

However, it may be dissolved by the Board of Directors of the Fund if they deem it useful to protect your interest.

## What are the risks and what could I get in return?

### **Risk Indicator**





The Recommended Holding Period of the product is 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you.
