You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as an Undertaking for Collective Investment in Transferable Securities (UCITS) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The assets of this Sub-Fund will be invested primarily in bonds or Eurobonds issued in EUR and listed on a recognized and regulated market. The Manager, Dôm Finance, may also invest in approved UCITS in accordance with Directive 2009/65/CE, up to 10% of its net assets. The selection criteria for bonds, convertible bonds, or equities include factors such as liquidity, safety, manager's performance consistency, talent, recognition, awards, and track record. The Sub-Fund may also invest in other securities (up to 10% of net assets). It can use derivatives for hedging and investment purposes, including futures/options on rates and stocks, not exceeding 100% of net assets. The Sub-Fund is actively managed without being tied to any benchmark index. Additionally, it may hold cash. Investments made by this Sub-Fund do not consider European Union criteria for sustainable economic activities in terms of environmental sustainability.

Intended investor

The Sub-Fund is suitable for an investor wishing to participate in the performance of the stock markets through equity-type investments. As stock market fluctuations may lead to capital losses, investors should be able to accept losses with a medium- to long-term investment horizon and have experience of volatile products and financial markets.

The Recommended Holding Period of the product is 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

How long should I hold it and can I take money out early?

The recommended investment horizon is at least 5 years. Shareholders can request full or partial redemption of their shares at any time by fax or letter to the Administrative Agent. Redemption requests received by 3pm CET on a valuation day are accepted at that day's NAV, paid within 3 business days. Redemptions over 10% of a sub-fund's NAV may be deferred to the next valuation day. Subsequent requests have priority. Cumulative deferral is limited to the time needed to accumulate liquidity.
