You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as an Undertaking for Collective Investment in Transferable Securities (UCITS) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The objective of the Sub-Fund is to actively manage investments primarily in Euro denominated corporate bonds of investment grade quality. Accessory investments include Euro issued government bonds of investment grade status, corporate bonds without ratings or no investment grade status, European regulated or over-the-counter structured funds investing predominantly in bonds or other eligible securities, other eligible securities (max. 10% of NAV), money market instruments, and liquidities. Underlying investments do not adhere to EU criteria for environmentally sustainable activities.

Intended investor

The Sub-Fund is suitable for an investor wishing to participate in the performance of the stock markets through equity-type investments. As stock market fluctuations may lead to capital losses, investors should be able to accept losses with a medium- to long-term investment horizon and have experience of volatile products and financial markets.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

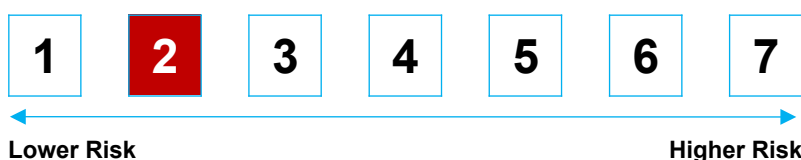

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. We have classified this Fund as 2 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you. You may lose up to the totality of the amount you have invested in the Fund. **Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the**

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average and best performances of the product over the last 10 years, by identifying, depending on the performance scenarios and as defined in Regulation (EU) 2021/2268, all overlapping sub-intervals individually (i) equal in length to the recommended holding period which start or end in each month which are contained within that period of 10 years or (ii) equal or shorter in length to the recommended holding period, but equal to or longer than 1 year, which end at the end of that period of 10 years. What happens if MC Square S.A. is unable to pay out?

Cost over time

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario;
- 10,000 EUR is invested.

How long should I hold it and can I take money out early?

The recommended investment horizon is at least 5 years. Shareholders can request full or partial redemption of their shares at any time by fax or letter to the Administrative Agent. Redemption requests received before 3pm CET on a valuation day are accepted at that day's NAV, paid within 7 business days. Redemptions over 10% of a sub-fund's NAV may be deferred to the next valuation day. Subsequent requests have priority. Cumulative deferral is limited to the time needed to accumulate liquidity.
