What is this product?

Туре

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as an Undertaking for Collective Investment in Transferable Securities (UCITS) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The Sub-Fund aims to maximize short-to-medium term (2-3 years) returns through discretionary management and opportunistic choices based on economic, financial, and market anticipations. It primarily invests in negotiable bonds and similar securities, up to 10% in approved ETFs or OPCVMs, and may hold cash. Investments can be made in authorized financial instruments including futures or options contracts on stocks, interest rates, currencies, or commodities, with derivatives exposure limited to 100% of net assets. Bond selection focuses on major OECD markets using a value-pick approach, favoring underperforming issuers expected to improve credit ratings or debt situations. Credit risk analysis considers internal and external assessments to find optimal risk/return ratios. This Sub-Fund does not consider EU environmental sustainability criteria.

Intended investor

The Sub-Fund is suitable for an investor wishing to participate in the performance of the stock markets through equity-type investments. As stock market fluctuations may lead to capital losses, investors should be able to accept losses with a medium- to long-term investment horizon and have experience of volatile products and financial markets.

How long should I hold it and can I take money out early?

The recommended investment horizon is at least 3 years. You can generally redeem your shares at any time. The redemption price will be paid in principle within 7 business days. In such cases, the redemption may be deferred until the next valuation day or spread over several valuation days.
