You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as an Undertaking for Collective Investment in Transferable Securities (UCITS) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The Sub-Fund aims for regular income while reducing capital loss risk. Minimum 80% will be invested in Euro denominated fixed income securities and up to 10% in UCITS/UCIs. No direct equity exposure, but up to 20% convertible bonds allowed. Up to 30% emerging market and 30% non-investment grade bonds, with 10% in emerging market high yield permitted. It invests in government and corporate bonds with flexibility on duration positioning. ESG factors are not considered in investments. The Sub-Fund is actively managed, can use structured instruments and derivatives for investment purposes or hedging and may hold ancillary liquid assets.

Intended investor

The Sub-Fund is intended for investors who are able to make an investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below. The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment. Dividend income: This class is a capitalisation class meaning that income is reinvested.

The Recommended Holding Period of the product is 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Performance Scenarios

The recommended investment horizon is at least 5 years. Shares can be redeemed daily on any Luxembourg Business Day. Redemption requests must be received before 2pm Luxembourg time on the Valuation Day to get that day's NAV. Payment within 2 Luxembourg Business Days after the Publication Day of the Valuation Day. The Fund may delay or scale down redemptions during exceptional circumstances like large redemptions. However, shares can be sold at any time and there are no lock-up periods. Early redemptions may impact performance.
