You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as an Undertaking for Collective Investment in Transferable Securities (UCITS) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The objective of the Sub-Fund is to generate positive returns annually, regardless of market conditions. To achieve this, the Sub-Fund can invest its net assets directly or indirectly (via UCITS or other UCIs) in various financial instruments without any geographical restrictions. These instruments include equities, equity-linked securities, fixed-income securities, depository receipts, warrants, participation rights and notes, and equity-linked notes. It can also invest in debt securities such as fixed or floating-rate bonds, convertible bonds, zerocoupon bonds, government and treasury bonds, and contingent convertible bonds (up to 10% of assets). Additionally, the Sub-Fund can utilize financial derivatives listed on regulated markets and/or over the counter for both investment purposes and hedging against portfolio risks, including currency rate risk, equity risks, and rate risk. It can also invest in Money Market Instruments, term deposits, and liquid assets primarily denominated in EUR, USD, JPY, CAD, NOK, SEK, CHF, with up to 40% of net assets denominated in other currencies. To achieve its objective, the Sub-Fund may take short positions on individual securities or selected equity markets using financial derivatives instruments based on underlying securities or equity indexes. The resulting total net exposure to equity securities, either directly or through derivatives, can range from -100% to +100% of the Sub-Fund's Net Asset Value. Long exposures (with a plus sign) and short exposures (with a minus sign) are considered when calculating the net exposure. The Sub-Fund's overall net equity exposure depends on the assessment of prospects for general equity markets and individual securities. Adverse impacts on sustainability factors are not considered due to market limitations and regulatory requirements. EU criteria for environmentally sustainable economic activities are not taken into account.

Intended investor

The Sub-Fund is intended for investors who are able to make an informed investment decision based on this document and the Offering Memorandum, and who have a risk appetite consistent with the risk indicator below. The Sub-Fund may be appropriate for those Investors who seek capital appreciation over the long-term, do not seek regular income and accept the risks associated with this type of investment. What are the risks and what could I get in return?





The Recommended Holding Period of the product is 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. We have classified this Fund as 4 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you. You may lose up to the totality of the amount you have invested in the Fund. Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment. If the Fund is not able to pay you what is owed, you could lose your entire investment. The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Liquidity risk, credit risk, counterparty risk, operational risk

Performance Scenarios

How long should I hold it and can I take money out early?

The recommended investment horizon is at least 5 years. Shares can be redeemed weekly on any Monday which is a Valuation Day, or the following Luxembourg Business Day if Monday is not a Business Day. Redemption requests must be received before 2pm CET the Luxembourg Business Day before the Valuation Day to get that day's NAV. Payment within 3 Luxembourg Business Days after Valuation Day. The Fund may delay redemptions during exceptional circumstances like liquidity constraints. Early redemptions may impact performance.
