You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as an Undertaking for Collective Investment in Transferable Securities (UCITS) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The objective of the Sub-Fund is to provide long-term capital growth by investing primarily in equity securities of small and midcapitalization biotechnology companies worldwide. The Sub-Fund aims to capitalise on investment opportunities in healthcare companies that target attractive addressable markets with strong medical needs and employ disruptive technologies. The Sub-Fund has flexibility to invest up to 20% in China A-shares. The Sub-Fund aims to outperform the SPDR S&P Biotech ETF benchmark in the long term. The Sub-Fund promotes environmental and social characteristics through integrating sustainability risks into investment decisions, though does not have sustainable investment as its primary objective.

Intended investor

The Sub-Fund targets eligible, well-informed investors including institutional, professional, and qualified private investors who meet defined expertise, knowledge and minimum investment thresholds. Investors must pass anti-money laundering checks, not be based in the US, and meet capital call deadlines.

Other information

Depository: ING Luxembourg S.A.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

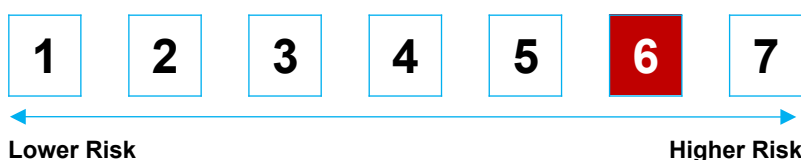
Conversion right: The investor may have the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

What are the risks and what could I get in return?

Risk Indicator



The Recommended Holding Period of the product is 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Fund is not able to pay you. We have classified this Fund as 6 out of 7, which is a high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the Fund's capacity to pay you. You may lose up to the totality of the amount you have invested in the Fund. **Be aware of currency risk. Performance Scenarios

What happens if MC Square S.A. is unable to pay out?

How long should I hold it and can I take money out early?

The recommended investment horizon is at least 5 years. Investors can submit redemption requests to take money out early, but there is a process and timeline to follow: Redemption requests must be received by the deadline of 4pm Luxembourg time 1 business day before the applicable valuation day; Redemption proceeds are paid out in the share class currency no later than 4pm Luxembourg time 2 business days after the applicable valuation day; In case of significant redemptions or lack of asset liquidity, payout may be delayed while asset sales are completed. Investors may receive a partial payout in advance of the final redemption amount. There is a process to follow with deadlines, and payout may be delayed in certain situations. But investors can submit requests to redeem early and take money out before the end of the recommended holding period.
