You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a share of a compartment (the "Sub-Fund") of an investment company authorised as an Undertaking for Collective Investment in Transferable Securities (UCITS) under Luxembourg law (the "Fund") in the form of a Société d'Investissement à Capital Variable (S.I.C.A.V).

Term

The Fund has no maturity date. Notwithstanding this provision, the Fund may be dissolved at any time by a resolution taken by the general meeting of shareholders.

Objectives

The Sub-Fund promotes good governance practices by investing in a portfolio of well-governed S&P 500 companies. It uses a proprietary technology to systematically select a limited number of S&P 500 companies that rank highest in terms of quality of governance. The Sub-Fund excludes investments in tobacco, defence, oil and gas companies. The investment objective is to provide significant long-term value by investing in a diversified portfolio of stocks that promotes organisations with long-term vision, social conscience, and that can make a positive impact. The investment policy seeks long term outperformance compared to the S&P 500 Total Return benchmark. The Sub-Fund promotes environmental and social characteristics under Article 8 SFDR, but does not have sustainable investment as its main objective or commit to sustainable investments. Investments do not take into account environmentally sustainable economic activities under the Taxonomy Regulation. The risk diversification principle underlies the investment strategy. Investments utilise leverage techniques in line with current market practice, within legal limits. Borrowing or leverage by one sub-fund does not impact other sub-funds.

Intended investor

The Sub-Fund is suitable for well-informed investors within the meaning of article 2 of the Luxembourg Law of 23 July 2016 related to reserved alternative investment funds, and have the financial ability and experience to understand, the willingness to accept and the financial resources to withstand the risk of loss inherent to a well-diversified product.

The Recommended Holding Period of the product is 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this Fund as 4 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at

Performance Scenarios

How long should I hold it and can I take money out early?

The recommended investment horizon is at least 5 years. Investors can submit redemption requests to take money out early, but there is a process and timeline to follow: Redemption requests must be received by the deadline of 4pm Luxembourg time 1 business day before the applicable valuation day; Redemption proceeds are paid out in the share class currency no later than 4pm Luxembourg time 2 business days after the applicable valuation day; In case of significant redemptions or lack of asset liquidity, payout may be delayed while asset sales are completed. Investors may receive a partial payout in advance of the final redemption amount. There is a process to follow with deadlines, and payout may be delayed in certain situations. But investors can submit requests to redeem early and take money out before the end of the recommended holding period.
